Maintain the investment for a minimum period of five years. Spend a minimum of seven days in Portugal during the first year, then not less than 14 days in each subsequent 2-year period.

- Have no criminal record
- Pass a detailed background check
- Be able to provide proof of source of funds if needed.
- No past rejection of UK and European Visit Visas.
- Be healthy
- Investors may apply with their spouse and dependent children, and, in some cases, dependent elderly parents or grandparents.
- Dependent children age varies from 25 - 30 years depending on the program.
